1. Reservation for display space will be made in the order in which the signed form with full payment is received. Availability of space will be on a first-come, first-served basis. MPI-CC reserves the right to reassign tabletop exhibit assignments.
2. Cancellations received in writing on or before Monday, August 23, 2010 will receive a 50% refund. No refunds will be issued after Monday, August 24, 2010.
3. Each tabletop exhibit is limited to one exhibiting company with a maximum of two staff members. No floor display units will be allowed. All displays must fit on the 6' table provided. Due to the layout and limited floor space, music will not be allowed at individual exhibit displays.
4. All exhibit displays should be completely set up by 12:00pm. Exhibit displays not set up by 12:00pm shall be forfeited by the exhibitor. Displays may not be dismantled until the official end time for the show. All items must be removed from the exhibit area by 5:00pm.
5. All matter and questions not covered by this document are subject to the decision of MPI-CC. MPI-CC shall have sole authority to promulgate, interpret and enforce all rules and regulations, and to make any amendments necessary for the orderly conduct of the event.
6. Each tabletop exhibit includes one meeting registration. All additional exhibitors must be individually registered for the MPI-CC meeting in order to exhibit and pay the member or nonmember registration fee.
